On 6-20-79 Baker & Taylor Drilling Co. (Rig #16) spudded a 12-1/4" hole at 9:00 PM. Drilled to a TD of 341' and ran 9-5/8" 40# casing set at 338'. Cemented with 175 sx Class C cement with 2% CACL. Plug down 11:30 AM 6-21-79. Circulated 15 sx cement. WOC 18 hrs. Tested casing with 1000# for 30 min. Test OK. Reduced hole to 8-3/4" and resumed drilling.
