

This is to report repairs to a leaking well head. Leak was discovered by rancher and reported to NMOCD 5-27-80. Leak was blowing 7'-10' in the air above ground level with an estimated flow of 50 to 70 MCFPD. Killed well by putting 30 bbl fresh water containing 3% KCL down casing. Pressure at start was 500# reducing to vacuum. Changed out wellhead pack off and left well shut-in. Leak was repaired 5-28-80 and report of repairs was telephoned to Mr. Dan Nutter NMOCD, Santa Fe by Ray Cox.
