This office has made numerous requests to have the above-referenced well fixed in order that there is no communication between the tubing and tubing-casing annulus. Temporarily-abandoned status on this well was approved on October 9, 1990 with the condition that the tubing or packer leak be repaired within ninety days. No attempt on your behalf to alleviate this situation has been observed by this office. Therefore, this office will take the appropriate legal action to plug this well should you not start repair work within the next thirty days.
