Attached is a copy of the latest correspondence pertaining to the subject drilling permits. A review of the well files suggest that your plans for these locations have changed several times, thus causing some confusion.

You will note that Well No. 1 (F-12-19N-30E) was started and abandoned in early 1980. Your request for cancellation of the permit, dated 2/17/80, has not been approved and cannot be approved because the well was actually started and some casing set. As of 9/3/81, that casing was open at the surface and you were advised accordingly. Following this, you requested the original permit to be kept in force - as evidenced by the attached.

An extension of your permit for Well No. 3 (A-14-19N-30E) was granted to 12/24/81. Obviously, this permit has long since expired; and it is also more than 10 months since your intent to drill No. 3 (see attached) was submitted.

Presumably, your plans have been changed again since there are numerous reports of drilling rigs being idle for several months. We would like to clear up the confusion presented by these two well files. Kindly put a top plug and marker on Well No. 1 and submit a report of same on Form C-103, unless you definitely are preparing to re-enter that site. Likewise, if you have a spud date in mind for Well No. 2<sup>3</sup>, kindly submit a Form C-103 for that location signifying such an intent; otherwise you may consider that permit as expired and cancelled.
