On 2-22-81 Salizar Brothers Drilling (Rig #13) spudded a 12-1/4" hole at 7:00 p.m. Drilled to a TD of 725' and ran 8-5/8" casing set at 725'. Cemented with 500 SX Class H cement. Plugged down 9:45 a.m. 2-24-81. Circulated 200 SX. WOC 18 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2708' and ran 5-1/2" casing set at 2708'. Cemented with 750 SX Class H cement. Plugged down 3:05 a.m. 3-2-81. Circulated 243 SX. Currently waiting on completion unit.
