Propose to kill well with 2% KCL water & release packer & POH tubing & packer. Perf intervals 227-2297, 2304-2314, 2316-2328, 2333-2337, 2341-2380, 2387,2404, 2420-2428. Replace 2-2/8" tubing. RIH with 1 jt fiberglass tailpipe, coated packer and 2-7/8" tubing to surface, land tailpipe at 2130 ft. Pump 2% KCL down backside and set packer at 2100'. Stim with 22 tons liquid CO2. Flow test overnight & return well to production.
