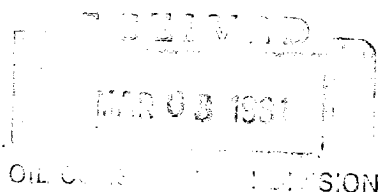

On 2-4-81 Royal Drilling (Rig #1) spudded a 12-1/4" hole at 12:30 p.m. Drilled to a TD of 720' and ran 8-5/8" casing set at 720'. Cemented with 500 SX Class H cement. Plugged down 3:30 a.m. 2-6-81. Circulated 200 SX. WOC 53 hrs. Tested casing with 800# for 30 min. OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2551' and ran 5-1/2" casing set at 2551'. Cemented with 925 SX Class H cement. Plugged down 3:30 p.m. 2-24-81. Circulated 175 SX. Currently waiting on completion unit.
