On 3-31-81 Royal Drilling (Rig #1) spudded a 12-1/4" hole at 8:00 p.m. Drilled to a TD of 727' and ran 8-5/8" casing set at 727'. Cemented with 500 SX Class H cement. Plugged down 6:10 p.m. 4-1-81. Circulated 172 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2638' and ran 5-1/2" casing set at 2638'. Cemented with 800 SX Class H cement. Plugged down 4:00 p.m. 4-5-81. Circulated 200 SX. Currently waiting on completion unit.
