On 4-3-81 Salizar Brothers (Rig #13) spudded a 12-1/4" hole at 5:30 a.m. Drilled to a TD of 716' and ran 8-5/8" casing set at 716'. Cemented with 500 SX Class H cement. Plugged down 3:40 p.m. 4-4-81. Circulated 250 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2572' and ran 5-1/2" casing set at 2572'. Cemented with 850 SX Class H cement. Plugged down 2:45 p.m. 4-9-81. Circulated 235 SX. Currently waiting on completion unit.
