On 1-17-81 Royal Drilling (Rig #1) spudded a 12-1/4" hole at 1:30 p.m. Drilled to a TD of 714' and ran 8-5/8" casing set at 714'. Cemented with 500 SX Class H cement. Plugged down 5:05 p.m. 1-19-81. Circulated 98 SX. WOC 28 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2405' and ran 5-1/2" casing set at 2404'. Cemented with 1200 SX Class H cement. Plugged down 10:00 p.m. 2-1-81. Circulated 75 SX. Currently waiting on completion unit.
