On 4-10-81 Moran Brothers (Rig #56) spudded a 12-1/4" hole at 3:00 a.m. Drilled to a TD of 710' and ran 8-5/8" casing set at 710'. Cemented with 500 SX Class H cement. Plugged down 7:30 p.m. 4-11-81. Circulated 215 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2297' and ran 5-1/2" casing set at 2297'. Cemented with 700 SX Class H cement. Plugged down 8:15 a.m. 4-18-81. Circulated 200 SX. Currently waiting on completion unit.
