11/22/97 - Cut tubing @ 2134'. Pull out of hole. Found hole in tubing. Circulate well with mud laden fluid. Pressure test 5-1/2" casing to 500 psi. Held. Spot 10 sacks Class C cement @ 2134' - 2036'. Spot 15 sacks Class C cement @ 1754' - 1606'. Spot 5 sacks Class C cement @ 30' - 3'. Cut off wellhead and anchors 3' below ground level. Cap well with steel plate. Install dry hole marker. Backfill pit and cellar. Clean location.
