On 2-21-81 James Drilling (Rig #7) spudded a 12-1/4" hole at 7:30 a.m. Drilled to a TD of 700' and ran 8-5/8" casing set at 700'. Cemented with 500 SX Class H cement. Plugged down 7:00 p.m. 2-22-81. Circulated 115 SX. WOC 19 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2419' and ran 5-1/2" casing set at 2419'. Cemented with 780 SX Class H cement. Plugged down 10:30 a.m. 3-2-81. Circulated 150 SX. Currently waiting on completion unit.
