On 4-15-81 C02 in Action (Rig #18) spudded a 12-1/4" hole at 4:00 p.m. Drilled to a TD of 735' and ran 8-5/8" casing set at 735'. Cemented with 500 SX Class H cement. Plugged down 12:15 p.m. 4-16-81. Circulated 175 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2365' and ran 5-1/2" casing set at 2352'. Cemented with 750 SX Class H cement. Plugged down 6:45 p.m. 4-21-81. Circulated 70 SX. Currently waiting on completion unit.
