Moved in service unit 9-18-81. Ran tubing. Spotted 100 gals 7-1/2% HCL acid and pulled tubing. Perf 2217-22', 28'-30', and 36'-42' w/2 JSPF. Ran packer and tubing w/packer set at 2198'. Acidized with 1000 gals 7-1/2% HCL. Swabbed. Slight show of gas on tubing. Pulled tubing and packer. Ran packer and tubing and set packer at 1919'. Fractured well with 21000 gals 40# gelled x-linked 2% KCL and tagged with radioactive material. Pulled tubing and packer. Ran 2-7/8" seating nipple. Moved out service unit 9-28-81. On 9-29-81 turned well thru a separator and flow tested for 168 hrs with an average of **2394** MCFD. Ran 72 hr BHP build-up 10-6-81 thru 10-9-81. Moved in service unit 11-10-81. Pulled 2-7/8" tubing. Ran seating nipple and 2-3/8" tubing w/tubing landing at 2107'. Moved out service unit 11-11-81. Well shut-in 11-11-81.
