On 3-11-81 CRC Colorado Drilling (Rig #66) spudded a 12-1/4" hole at 1:00 a.m. Drilled to a TD of 705' and ran 8-5/8" casing set at 704'. Cemented with 500 SX Class H cement. Plugged down 7:00 a.m. 3-12-81. Circulated 75 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2340' and ran 5-1/2" casing set at 2340'. Cemented with 900 SX Class H cement. Plugged down 9:30 a.m. 3-20-81. Circulated 100 SX. Currently waiting on completion unit.
