On 3-9-81 Royal Drilling (Rig #1) spudded a 12-1/4" hole at 1:00 p.m. Drilled to a TD of 702' and ran 8-5/8" casing set at 702'. Cemented with 500 SX Class H cement. Plugged down 4:00 a.m. 3-11-81. Circulated 195 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2349' and ran 5-1/2" casing set at 2349'. Cemented with 700 SX Class H cement. Plugged down 5:15 a.m. 3-16-81. Circulated 200 SX. Currently waiting on completion unit.
