On 3-2-81 Calvert Western Drilling (Rig #5) spudded a 12-1/4" hole at 11:45 p.m. Drilled to a TD of 676' and ran 8-5/8" casing set at 676'. (Received verbal permission to set 8-5/8" casing at 676' instead of approved depth of 700' per Telecon Gary Massie to Dan Nutter 3-5-81). Cemented with 500 SX Class H cement. Plugged down 4:15 p.m. 3-5-81. Circulated 50 SX. WOC 18 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2279' and ran 5-1/2" casing set at 2279'. Cemented with 725 SX Class H cement. Plugged down 1:30 p.m. 3-18-81. Circulated 225 SX. Currently waiting on completion unit.
