Propose to repair tubing/packer leak as follows:

Kill well with 2% KCL water. Pull tubing and packer. Run in hole with tubing and packer using thread lubricant on box to seal connections. Pump annular volume of 2% KCL inhibited water down backside and set the packer. Finish loading backside to surface. Pressure test backside. Swab to kick well off. Flow 2 hours to recover load water. Shut-in the well.
