On 3-21-81 Layton Exploration (Rig #2) spudded a 12-1/4" hole at 11:30 p.m. Drilled to a TD of 711' and ran 8-5/8" casing set at 707'. Cemented with 500 SX Class H cement. Plugged down 8:30 p.m. 3-23-81. Circulated 210 SX. WOC 19 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2330' and ran 5-1/2" casing set at 2330'. Cemented with 780 SX Class H cement. Plugged down 6:30 p.m. 3-30-81. Circulated 200 SX. Currently waiting on completion unit.
