On 3-2-81 CRC Colorado (Rig #52) spudded a 12-1/4" hole at 8:00 a.m. Drilled to a TD of 730' and ran 8-5/8" casing set at 730'. Cemented with 500 SX Class H cement. Plugged down 4:55 a.m. 3-4-81. Circulated 204 SX. WOC 18 hrs. Tested casing with 900# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2343' and ran 5-1/2" casing set at 2343'. Cemented with 750 SX Class H cement. Plugged down 8:45 a.m. 3-11-81. Circulated 230 SX. Currently waiting on completion unit.
