On 3-24-81 Moran Brothers (Rig #52) spudded a 12-1/4" hole at 2:00 a.m. Drilled to a TD of 710' and ran 8-5/8" casing set at 710'. Cemented with 500 SX Class H cement. Plugged down 12:30 a.m. 3-25-81. Circulated 200 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2854' and ran 5-1/2" casing set at 2854'. Cemented with 600 SX Class H cement. Plugged down 6:30 a.m. 3-30-81. Circulated 131 SX. Currently waiting on completion unit.
