On 2-7-81 CRC Colorado Drilling (Rig #77) spudded a 12-1/4" hole at 4:30 p.m. Drilled to a TD of 702' and ran 3-5/8 casing set at 702'. Cemented with 550 SX Class H cement. Plugged down 11:45 a.m. 2-9-81. Circulated 96 SX. WOC 19 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2675' and ran 5-1/2" casing set at 2669'. Cemented with 750 SX Class H cement. Plugged down 11:45 p.m. 2-16-81. Circulated 180 SX. Currently waiting on completion unit.
