Propose to kill well with 2% KCL water. Release packer and POH tubing and packer. Perf intervals 2340-2354, 2366-2386, 2408-2414, 2418-2460, 2486-2502, 2527-2546. RIH with 1 jt fiberglass tailpipe, coated packer and 2-7/8" tubing to surface. Land tailpipe at 2190 and set packer at 2160'. Stim with 22 tons liquid CO2. Flow test overnight and return well to production.
