Opened well to tank and perforated 2440-56', 2461-68', 2476-2512', 2518-27', 2532-52', 2564-80', 2584-94', 2602-22' with 2SPF. Killed well and ran 2 7/8" production tubing and packer. Tubing landed at 2303' and packer set at 2273'. Pressure tested casing and packer 1000 psi-ok. Stimulated with 25 tons CO₂ and 576 ball sealers. MISU 7-15-85 and returned well to production. Operations Completed 9-25-85.
