Moved in completion unit 4-26-81. Drilled cement and DV tool 1073'-1122'. Perforated 2168'-74', 2186'-98' with 2 JSPF. Acidized with 2400 gal. 7-1/2% HCL and 80 ball sealers. Swab test 38 hrs. and recovered 20 bbls. load water. Fractured with 10000 gal. CO2 10000 gal. 30# gel in 2% KCL, 26000# 10/20 sand, 6000# 8/12 sand, and radioactive material. Flow tested thru a separator for 63 hrs. with an average of 49 MCFD. Well shut-in 5-7-81.
