Moved in completion unit 8-5-81. Ran bit and drilled out to 2782'. Perforated 2462'-78', 2481'-93', 2499'-2507', 2522'-30', 2546'-59' w/2 SPF. Acidized with 1900 gal. 7-1/2% HCL and 100 ball sealers. Fractured well with 2 1000 gal. 40 lb.gel and 23000# 8/12 sand. Flow tested thru a separator for 120 hrs. with an average of 2607 MCFD. Shut-in 8-22-81 for BHP build up. Pulled BHP bomb 8-25-81. Well shut-in 8-25-81.
