On 8-24-83 Aztec Drilling (Rig #56) spudded a 12-1/4" hole at 12:15 pm. Drilled to 1298' and set 9-5/8" casing. Cement with 700 sacks class H and additives. Bump plug at 2:00 am on 8-26-83. Circulated 200 sacks. Test casing for 30 min. at 600 psi and OK. Ran 7" casing and set at 2452'. Cement with 500 sacks class H. Plugged down at 1:00 am. 8-29-83. Rig released at 3:00 am on 8-29-83. Currently waiting on completion unit.
