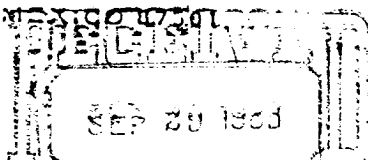

On 8-29-83 Aztec (Rig #56) spudded a 12-1/4" hole at 7:30 pm. Drilled to 710' and set 9-5/8" casing. Cemented with 375 sacks class H and additives. Plugged down at 6:00 pm on 8-30-83 and circulated 200 sacks. Tested casing at 600 psi for 30 min. and OK. Logged and ran 7" casing and set at 2589'. Cemented with 800 sacks class H and additives. Circulated 480 bbl to pit. Plugged down at 10:04 am on 9-5-85. Rig released at 11:59 on 9-5-83. Currently waiting on completion unit.
