On 9-6-83 Aztec (Rig #56) spudded a 12-1/4" hole at 3:45 pm. Drilled to 710' and set 9-5/8" casing. Cemented with 375 sacks class H and additives. Circulated 160 sacks and plugged down at 11:00 am on 9-7-83. Tested casing at 600 psi for 30 min. and Ok. Pumped 12 #/bbl LCM. Logged and ran 7" casing and set at 2668'. Cemented with 800 sacks class H and additives. Plugged down at 8:30 pm on 9-10-83. Circulated 220 sacks to pit. Rig released at 10:30 pm on 9-10-83. Currently waiting on completion unit.
