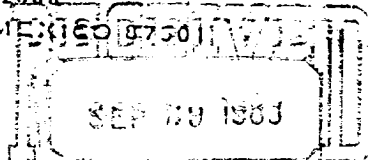

On 9-13-83 CO2-In-Action (Rig No. 18) spudded a 12-1/4" hole at 1:00 pm. Drilled to 700' and set 9-5/8" casing. Cemented with 375 sacks class H and additives. Plugged down at 3:45 pm on 9-14-83. Tested casing at 600 psi and OK. Circulated 20 sacks cement to pit. Logged and ran 7" casing and set at 2675'. Cemented with 1150 sacks class H and additives. Circulated 158 sacks to pit. Plugged down at 4:45 am on 9-19-83. Rig released 9-19-83. Currently waiting on completion unit.
