On 8-25-83 CO2 in Action Drilling (Rig No. 18) spudded a 12-1/4" hole at 8:30 pm. Drilled to 1503' and 9-5/8" casing set. Cement with 800 sacks class H and additives. Circulated 200 sacks cement and plugged down at 8:20 am on 8-27-83. Test casing 30 min at 600 psi and OK. Pump 200 bbl mud and 5#/bbl LCM with no returns. Pump 100 bbl 20#/bbl LCM pill and 20 bbls mud with full returns. Logged from TD to 1503'. Ran 7" casing and set at 2738'. Cement with 500 sacks class H and additives. Plugged down at 12:15 pm on 8-31-83. Circulated 60 sacks cement. Rig released at 2:30 pm on 8-31-83. Currently waiting on completion unit.
