Set packer at 2223' and pressure tested 1000 psi-ok. Fractured with 224 BW 2% KCl, 69 Tons CO₂, and 74,896# 8/16 sand. Flowed back 2 hrs and killed well. Released packer and POH with workstring. Re-ran production equipment and set packer at 2294'. MISU 8-12-85 and flow tested well for 92 hrs. Operations completed 9-17-85. PAWD: 946 MCFD. Returned well to production.
