Traced down casing with 259 BGW, 43800 lbs 10/20 sand, 66 tons CO₂. Max pres 1700 psi, Aug pres 1400 psi, Air 35 BPM, ISIP 1054 psi, 5 MIN SIP 920 psi 10 MIN SIP 787 psi, 15 MIN SIP 636 psi. Jagged fall at 2590 Cleaned out sand 2590-2655 PBTD. Ran tubing and packer and packer set at 2444. Pressure test casing to 500 psi and held O.K. Moved out service unit 12/20/93.
