Fractured with 25,000 gals CO₂ foam and 73,000# 8/12 Brady Sand. Cleaned out sand fill to 2640'. Re-ran production packer and tubing. Set packer at 2314' and landed tubing at 2345'. MISU 11-21-85 and flow tested 96.5 hrs. Returned well to production and completed operations 1-2-86.
