Moved in rigged up mast unit 2-3-84. Ran base survey. Pumped 8 bbls fresh water with 2% KCL and killed well. Installed Howco valve and well started to flow. Ran base Noise log and temperature survey. Pressured backside to 1000 psi. Pumped 13 tons CO2 and displaced with 5 tons CO2. Ran noise log, temperature survey, and temperature decay survey. Turned over to mock test. Flow tested for 7 days with an average of 630 MCFD. Pulled 144 hr. BHP build-up test on 2-18-84. Well shut-in.
