Circulated 180 sacks to pit and plugged down at 7:15 am on 10-26-83. Test casing at 600 psi and OK. Logged ran 7" casing set at 2687'. Cemented with 750 sacks class H and additives. Circulated 203 sacks cement and plugged down at 7:30 pm on 10-29-83. Tested casing at 1500 psi for 30 min. and OK. Rig released at 10:00 pm on 10-29-83. Currently waiting on completion unit.
