Moved in service unit 12-2-84. Ran swab unit and recovered 105 blw in 4 hours. Perforated intervals 2505-2512, 2522-2524, 2531-2535 with 2 JSPF. Ran 3½" tubing with 3½" packer and set packer at 2339 ft. On 12-4-84 stimulated well with 34 bbl liquid CO2 and pump 28 bbl liquid CO2 with 4 1.15 gravity ball sealers per bbl. Rigged down and moved out service unit 12-4-84. Flow tested through a separator for 144 hours at an average rate of 96 MCFD.
