Moved in and rigged up service unit 11-26-84. Nipple up and test casing with 1500 PSI and test ok. On 11-28-84 perforated intervals 2496-2507 and 2514-2517 with 2 JSPF. Ran and set packer at 2369 ft. Stimulated well with 34 bbl CO2 and pump 28 BBL CO2 and 4 Ball sealers per barrel. Flush 22 bbl CO2 with maximum pressure 7850 PSI. Rigged down and moved out service unit 11-27-84. Flow tested through a separator for 144 hours at an average rate of 38 MCFD.
