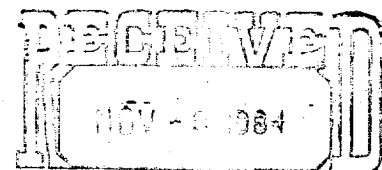

On October 26, 1984 C02 in Action, Rig #16, spudded a 12 1/4" hole. Drilled to a total depth of 724' and set 9-5/8" Casing. Cemented with 390 sacks Class H cement with additives. Plugged down at 4:30 a.m. on 10-27-84. Circulated 90 sacks cement to reserve pit. Wait on cement for 12 hours. On 10-31-84 ran and set 7" casing at 2832'. Cemented with 1100 sacks Class H cement with additives, plugged down at 7:00pm on 10-31-84. Circulated 165 sacks Class H cement. Rig released 10:00pm 10-31-84.
