On October 7, 1984 CO2 in Action, Rig 16, spudded a 12 1/2" hole and drilled to a total depth of 728 feet. On October 7, 1984 ran and set 9-5/8" casing at 714 ft. Cemented with 390 sacks class H Cement with additives. Plugged down at 8:15am on October 7, 1984. Circulated 138 sacks cement to reserve pit. Pressure test casing to 600 PSI. On October 12, 1984 ran 7" casing and set at 2757 ft. Cemented with 1250 sacks class H cement with additives. Circulated 343 sacks to reserve pit. Plugged down 7:00am on October 12, 1984. Rig released 10:00am on October 12, 1984.
