On October 13, 1984, C02 in Action Rig #16, spudded a 12 1/4" hole and drilled to a total depth of 250'. On October 14, 1984 ran and set 9-5/8" casing at 698'. Cement with 390 sacks Class H cement with additives. Circulated 121 sacks to reserve pit. Plugged down at 3:45pm on 10-13-84. On 10-18-84 ran set 7" casing at 2762'. Cemented with 950 sacks Class H cement with additives. Plugged down with 1400 PSI on 10-18-84. Circulated 275 sacks cement to reserve pit. Rig released 7:30pm on 10-18-84.
