Wait on Cement for 12 hours. Plugged down at 11:45 am on 11-16-84. On 11-22-84 ran and set 7" casing at 2682 ft. Cemented with 600 sacks Class H cement with additives. Plugged down at 11:25 am on 11-22-84. Circulated 225 sacks cement to reserve pit. Rig released 12-1-84 at 12:01 pm.
