Moved in and rigged up service unit 11-27-84. On 11-28-84 nipple up wellhead and test casing with 1500 psi. Ran swab unit and IFL surface. Recover 100 BLW in 3 hours and flow 2600 ft from surface. Stimulate well with 34 bbl CO2. Pump 28 bbl CO2 and 2 balls per bbl and flush with 22 BBL CO2 with maximum pressure 3000 psi and air. Rigged down and moved out service unit 11-29-84. Flow tested through a separator for 144 hours at an average rate of 87 MCFD.
