On 8-29-85, Siton Rig No. 1 spudded the subject well with a 12 1/4" bit. Drilled to a total depth of 720'. On 8-30-85, ran 9 7/8" 36# K-55 casing and set at 720'. Cemented casing with 415 SX class H cement. Circulated 100 SX to pit. WOC 18 hrs. Pressure tested casing 1000 psi for 30 mins - ok. Reduced bit to 8 3/4" and resumed drilling. Drilled to TD at 2325'. On 9-4-85, ran 7" 23# K-55 casing and set at 2320'. Cemented with 1,034 SX Class H cement. Circulated 463 SX of cement to pit. Rig released 4:00 am. 9-5-85. No further report until move in completion unit.
