MISU 9-23-85. Drilled out to 2630', circulated, and tested csg to 1500 psi, OK. Swabbed 100 BW, final fluid level 2600' from surface. Perforated 2362'-2590', .49" diameter, w/2 SPF. Killed well and RIH with tbg and pkr. Tbg landed at 2230' and pkr set at 2198'. Stimulated well with 22 tons CO₂. Swab and flow tested well. Last 24 hrs flowed 2299 MCF and 2 BLW. Well is currently shut in. Operations completed 10-4-85.
