Sutton Rig #1 spud the well 10-1-85 with a 12 1/4" bit. Drilled to TD of 724' and on 10-1-85 set 9 5/8", 36", K-55, csg. Csg set at 724' and cemented with 390 sxs class H w/add. Circulated out 100 sxs. WOC 18 hrs and tested csg to 1200 psi for 30 min, OK. Reduced bit to 8 3/4" and drilled to TD of 2683'. On 10-5-85 set 7", 20", K-55 csg. Csg set at 2683' and cemented with 900 sxs class H w/add. Plugged down and circulated out 300 sxs. Rig released 10-5-85. No further report until MISC.
