MIRU Exeter Drlg, spudded 12 1/4" hole @ 2330MST 11/23/90. Drill 12 1/4" hole to a TD-608'. Run 14 jts 9 5/8" 36# K-55 csg and set @ 608'. Cement w/ 500sx Cl H + 2% CaCl₂. Plug down @ 0445MST 11/25/90. Circ 138sx cmt to pit. NMOCD notified but did not witness. WOC 8 hrs, weld on 9 5/8" X 11" 2000# WH & NU 10" 3000# BOP. Test csg, WH, & BOP to 1500#, held OK. Resume drlg 8 3/4" hole @ 2230MST 11/25/90.

Drill 8 3/4" hole to a TD-2925'. Run 69jts 5 1/2" 15.5# K-55 csg and set @ 2919'. Cement w/ 900sx Cl H + 2% CaCl₂ + 2% gel + 5% KCl + .4% Halad-4 + 5#/sx gilsonite + 1/4#/sx flocele. Plug down @ 2100MST 11/30/90. Circ 100sx to pit. NMOCD notified but did not witness. ND BOP, set slips, NU WH test to 2000# held OK. Release rig, WOCU.
