
Dear Mr. Nutter:

Answering yours of February 2nd, attached are the three copies of the surveyor's plat of our well location that you asked be submitted to you within 15 days.

You will note from the surveyor's plat that the location of the proposed well has been changed from what we originally planned. The maps that we located our first choice from proved to be in error as far as Ute Creek's location was concerned. When the surveyor went up last week he found that our original choice was on the west side of Ute Creek, and for this first well we preferred being on the east side.

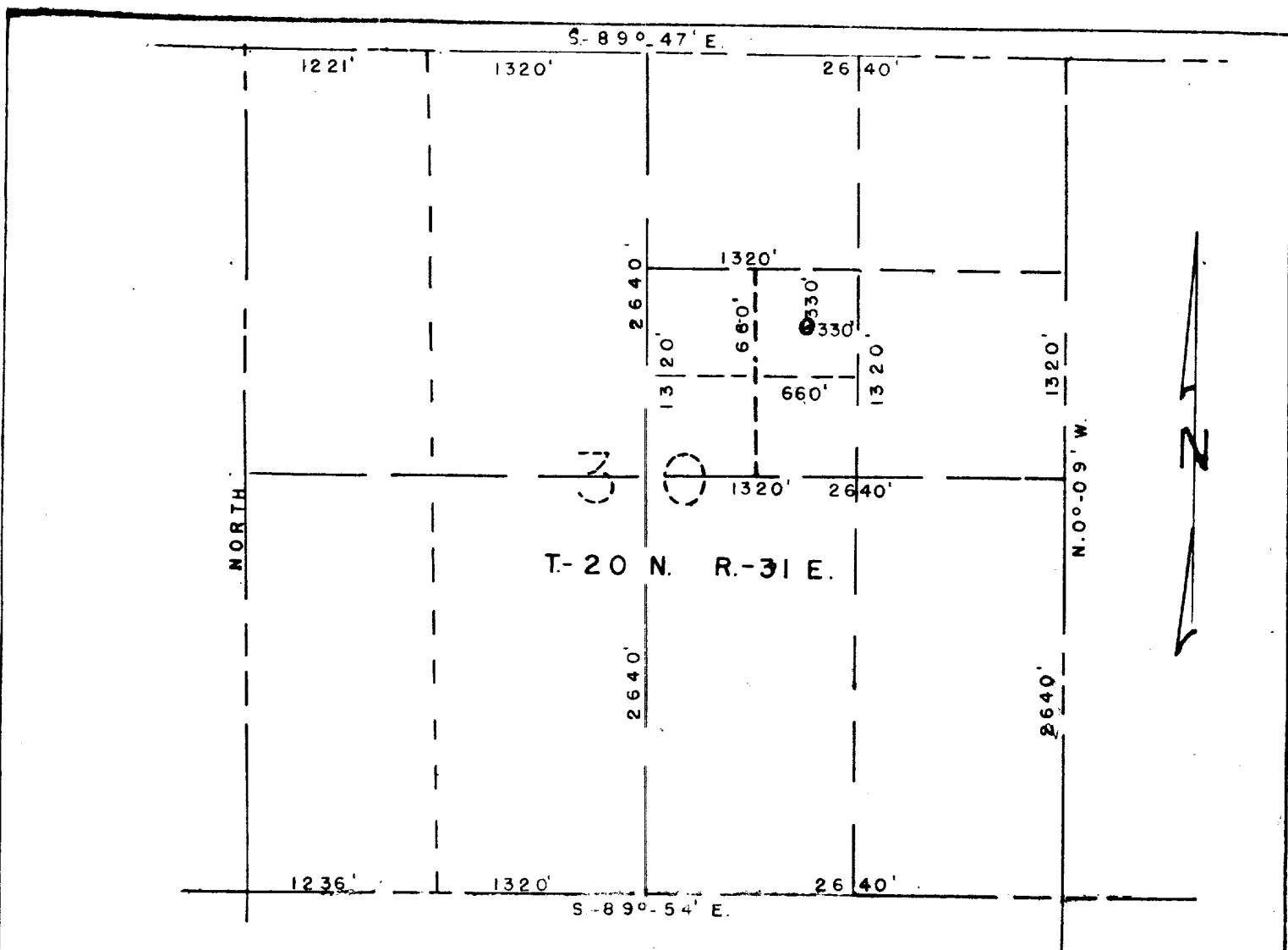

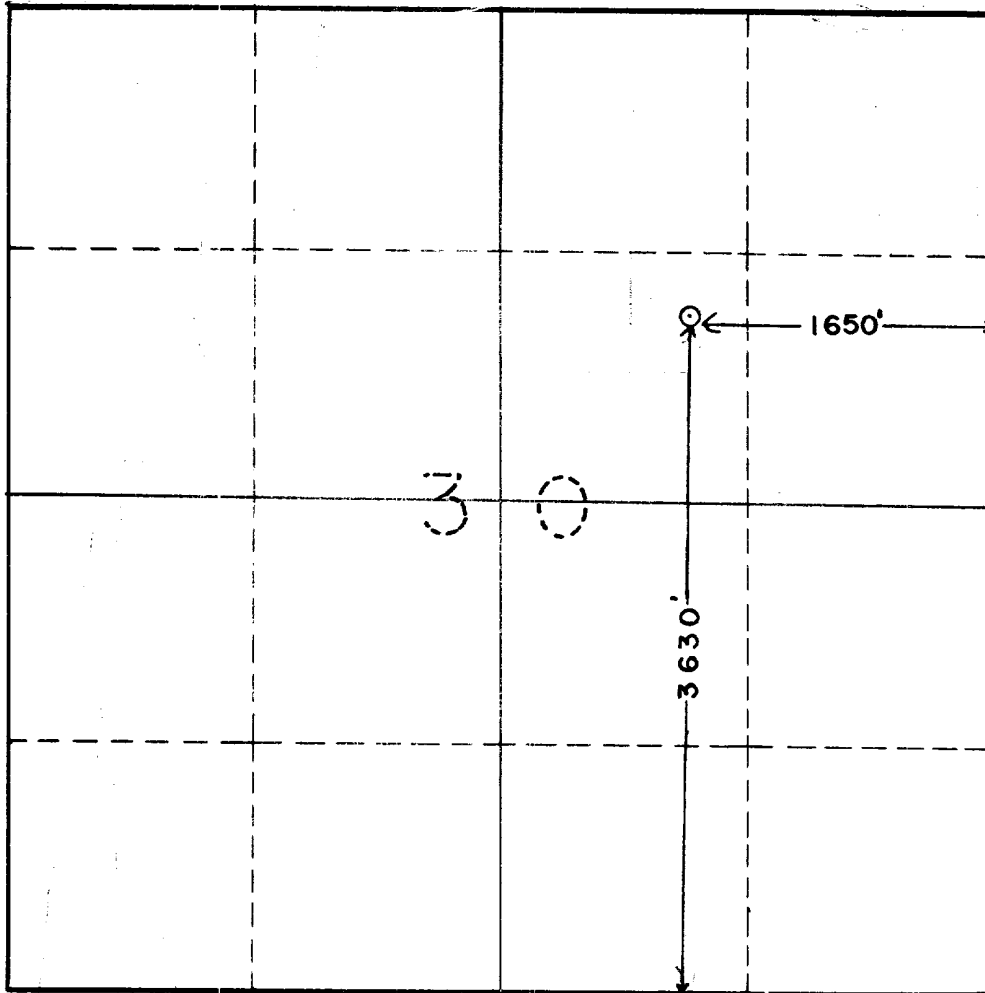
