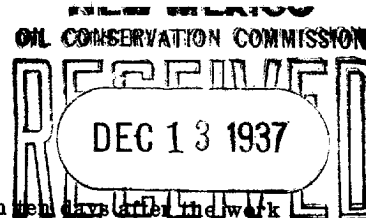

It should be signed and sworn to before a notary public for reports on beginning drilling operations, results of shooting well, results of test of casing shut-off, result of plugging of well, and other important operations, even though the work was witnessed by an agent of the Commission. Reports on minor operations need not be signed and sworn to before a notary public. See additional instructions in the Rules and Regulations of the Commission.

Cemented the bottom of the well with 8 sacks of cement properly mixed.  
Cemented the casing at top of gas sand, to surface of the ground, using  
89 sacks cement placed under pressure by Halliburton well cementing co.  
Drilled out and cleaned out, dry and bailed out and found dry of Sept  
18th, and on the 20th of Sept, well tested and approved by A. Andreas  
on September 23rd, all in 1937.
